#### **EXECUTIVE COMMITTEE MEETING MINUTES**

June 13, 2019

Drema Isaac called the meeting to order at 9:30 am at Christian Financial Credit Union in Sterling Heights.

### PREVIOUS MEETING MINUTES:

Motion was made by Jennifer Nelson and supported by Steve Andrews to approve the minutes of the May 2, 2019 regular meeting. Motion carried.

### TREASURER'S REPORT (Report attached):

Steve Andrews reported \$1,000 in deposits for charity with a Friends of Foster Kids check outstanding. A motion to accept the Treasurer's Report was made by Theresa Hing and supported by Fabian Ellis. Motion carried.

### **GOVERNMENT AND POLITICAL AFFAIRS FORUM:**

Jennifer Martines reminded the group of the Legislative Breakfast coming up on June 17. The chapter received a RSVP from Congressman Paul Mitchell, who is expected to attend in person. Representatives from both Senator's offices and other state lawmakers should be in attendance. About 25 credit union representatives have RSVP'd. To date there has been no progress on the data breach legislation.

#### MCUL DIRECTOR:

Drema Isaac reported. Chapter board elections occurred after the AC&E. Karen Church of ELGA Credit Union will remain the chairperson for the MCUL.

### **PROGRAM & EVENTS:**

Gail Hernalsteen reported that the committee is gearing up for the golf outing on Sept. 9. The committee has reached out to Mortgage Center to be the presenting sponsor again this year. The committee is looking into soliciting vendors from the AC&E for golf outing sponsorships.

### **CU DIFFERENCE (Report attached):**

Megan White reported that the new "Anthem" CU Link Open Your Eyes to a Credit Union spot ran during the AC&E with new images and touchpoints for key messages. There are five more :15 spots being produced, slotted for the end of July with previews available soon. Megan has the national campaign statistics from CUNA if anyone is interested. Gail Hernalsteen mentioned that Motor City Co-op Credit Union will be focusing

on the "Open Your Eyes" for member messaging this year and encouraged other chapter credit unions to do the same.

### **CHARITY COMMITTEE (Report attached):**

Ashley Maye reported the following:

- The chapter has raised \$12,400 for Rainbow Connection. The chapter will do a check presentation on June 26 at Freedom Hill for the charity's Family Picnic event. The committee will draft a press release to send out after the check presentation.
- The next charity is Operation Care Package and the chapter will be raising funds to pay for shipping the boxes to soldiers overseas.
- The committee will also do a check presentation with Friends of Foster Kids next week during their Senior Sendoff brunch.
- The committee is looking for a volunteer to spearhead a large volunteer effort, TBD.

### MEGAC (Report attached):

Amanda Troia reported on the following:

- We have already raised \$14,296.04 for the State PAC and we have already met our goal for the year.
- We are still far from meeting our Federal PAC goal but we expect to easily meet it with the Grand Raffle funds.
- There are a few Grand Raffle changes this year, including 10 3<sup>rd</sup> place prizes of \$1,000. In addition, credit unions can only sell tickets to their own credit union members. If a member purchases \$50 or more worth of tickets at one time, you must also fill out the Federal PAC remittance form that comes with the tickets.

### **MCUL REPRESENTATIVE:**

Stephanie Heidt reported on the following:

- There are currently 222 credit unions in the state of Michigan with no mergers, name changes or liquidations in May.
- The MCUL is currently watching five mergers.
- The ASFM golf outing will be held on July 17, Capitol Day on Sept. 24<sup>th</sup> and Executive Summit on Sept.
   11. Fall Leadership, Call Center conference and Telephone collections schools are coming up with dates to be announced.
- Update your Sprint banner on your credit union website to automatically fulfill marketing requirements.
- The Love My Credit Union member-facing website has been revamped. The employee-facing one will be revamped soon.
- The Marketing Solutions team is offering meetings with Tracy Reihm at no cost to meet with her for strategic advising sessions.
- There is a compliance bootcamp e-series coming up for Credit Union CEOs and SVPs. There are four sessions online an hour each with information on how to become a compliance officer. Total cost is \$799 and scholarships are available.
- CU Solutions Group announced a partnership with NestReady, like Autosmart for home buying.
- There is an E-series webinar coming up on training for Elder Abuse that can be used as part of a credit union's BSA program. Financial literacy training for the Board of Directors is also available.

Gail Hernalsteen reported she is working on uploading minutes to the new website.

### **OLD BUSINESS:**

### **NEW BUSINESS:**

Drema Isaac represents Metro East on the MCUL's vision task force to re-envision the structure of chapters and districts in Michigan.

- The League proposed moving from 10 to seven districts with seven board members and seven alternates with a total of 14 board members.
- Michigan will still have chapters in addition to districts. Metro East could be merged with the Oakland Chapter to be in the same district. We would need to determine if we would merge chapters.
- Two at-large positions could also be available, one position for a large asset-size credit union and one position for a small asset size credit union.
- Nothing will likely change until the annual meeting next year.

**NEXT MEETING DATE:** The next meeting date will be held on Sept. 5. Meeting will be held at Motor City Co-op Credit Union in Roseville.

### Video:

Delivered over 4.7 million impressions in June. Video completion rate was again over 80%.

CU Link Video Completion Rate: 84.24%

### Audio:

Delivered 4.6 million impressions with an audio completion rate of 99%, which led to a cost per completed listen of \$0.013.
